

**Brickell City Centre Sweepstakes  
OFFICIAL RULES**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.**

**ELIGIBILITY:** The Brickell City Centre Sweepstakes (the "**Sweepstakes**") is open to legal residents of the United States who are 21 years of age or older. Employees, officers or directors of either Swire Properties, Brickell City Centre, Brickell City Centre Restaurants, or Puttshack (collectively, "**Sponsor**"), or any of their parents, subsidiaries, affiliates, or any advertising or promotion agencies involved in this Sweepstakes (collectively, the "**Sweepstakes Entities**"), as well as the immediate family and household members of each such person, are not eligible to participate. Void prohibited.

**HOW TO ENTER:** During the Sweepstakes Period, show your receipt for a purchase made at BCC shops between 3/24/25 and 3/30/25. Enter through Brickell City Centre's Instagram by following @brickellcitycentre, tagging a friend and commenting the shop that you will pick on the sponsor Instagram "Sweepstakes Post". Limit one (1) entry per person/account. Any attempt to enter more than one (1) time via multiple names, email addresses, Instagram accounts, or any other means, may result in disqualification from this and any other promotional event.

Sponsor's database computer is the official time-keeping device for the Sweepstakes. Entries will not be acknowledged or returned. In the event of a dispute over the identity of an entrant, entry will be deemed submitted by the authorized account holder of the email address associated with the social media account used to post the entry. "Authorized account holder" is defined as the natural person who is assigned to an email address or other similar account associated with the relevant Instagram account.
